

## From the announcement of the National Electoral Commission

of 11 October 2011

on the results of the elections to the Sejm of the Republic of Poland  
held on 9 October 2011

The elections were conducted by: the National Electoral Commission, 41 constituency electoral commissions and 25 993 district electoral commissions. 202 376 voters were appointed members of district electoral commissions. The number of persons having the right to vote equaled 30 762 931, 22 951 voters were sent electoral packets. 15 053 754 persons were given ballot papers, 12 427 of which – on the basis of presented letters of attorney.

The voter turnout equaled 48,92%.

The number of invalid ballot papers equaled 13 918.

The number of valid ballot papers equaled 15 050 027.

The number of null and void votes equaled 680 524, which is 4,52% of the total number of votes.

The number of valid votes equaled 14 369 503, which is 95,48% of the total number of votes.

460 Deputies from among 7035 candidates registered on 338 lists of candidates by 11 electoral committees.

### RESULTS OF VOTING IN CONSTITUENCIES SUMMARY

The following lists of candidates received the following number of valid votes nationwide:

- lists no. 1 registered by the **Law and Justice (Prawo i Sprawiedliwość) Electoral Committee** received 4 295 016 votes, which is 29,89%;
- lists no. 2 registered by the **Poland Comes First (Polska Jest Najważniejsza) Electoral Committee** received 315 393 votes, which is 2,19%;
- lists no. 3 registered by the **Democratic Left Alliance (Sojusz Lewicy Demokratycznej) Electoral Committee** received 1 184 303 votes, which is 8,24%;
- lists no. 4 registered by **Palikot's Movement (Ruch Palikota) Electoral Committee** received 1 439 490 votes, which is 10,02%;
- lists no. 5 registered by the **Polish People's Party (Polskie Stronnictwo Ludowe) Electoral Committee** received 1 201 628 votes, which is 8,36%;
- lists no. 6 registered by the **Polish Labour Party – August '80 (Polska Partia Pracy – Sierpień 80) Electoral Committee** received 79 147 votes, which is 0,55%;
- lists no. 7 registered by the **Civic Platform (Platforma Obywatelska RP) Electoral Committee** received 5 629 773 votes, which is 39,18%;
- lists no. 8 registered by **Our Home Poland – Andrzej Lepper's Self-Defense (Nasz Dom Polska – Samoobrona Andrzeja Leppera) Electoral Committee** received 9 733 votes, which is 0,07%;

- lists no. 9 registered by the **New Right Party – Janusz Korwin-Mikke (Nowa Prawica Janusza Korwin-Mikke) Electoral Committee** received 151 837 votes, which is 1,06%;
- lists no. 10 registered by the **Right (Prawica) Electoral Committee** received 35 169 votes, which is 0,24%;
- list no. 11 registered the **German Minority Voters Electoral Committee (Komitet Wyborczy Wyborców Mniejszość Niemiecka)** in the constituency no. 21 received 28 014 votes, which is 0,19%.
