

58th SITTING OF THE SEJM, 8–10 JANUARY 2014

THE SEJM PASSED THE ACTS

- on participation of foreign officials or employees in joint operations or joint rescue operations on the territory of the Republic of Poland;
- amending the Code of Civil Procedure;
- amending the Electoral Code (*of print no. 1983*);
- amending the Electoral Code (*of print no. 1945*);
- ratifying the Internal Agreement between the Representatives of the Governments of the Member States of the European Union, meeting within the Council, on the financing of European Union aid under the multiannual financial framework for the period 2014 to 2020, in accordance with the ACP-EU Partnership Agreement, and on the allocation of financial assistance for the Overseas Countries and Territories to which Part Four of the Treaty on the Functioning of the European Union applies, drawn up in Luxembourg and Brussels, on 24 and 26 June 2013, respectively.

THE SEJM ADOPTED RESOLUTIONS

- concerning granting the consent of the Sejm of the Republic of Poland to bring Deputy Zbigniew Dolata to criminal accountability;
- concerning changes within personal composition of the Sejm committees.

THE SEJM CONSIDERED THE SENATE'S RESOLUTION CONCERNING THE ACT amending the act on information processing with reference to the activities of entities performing public tasks and some related acts (*The Senate's amendments were accepted*).

THE SEJM RETURNED TO COMMITTEES

- Deputies' bill amending the Building Law and the act on spatial planning and order;
- Senate's bill amending the act on veterans and particular persons – victims of war and postwar repressions, deputies' bill on the Corps of Veterans of the

Struggle for the Independence of the Republic of Poland and government bill amending the act on veterans and particular persons – victims of war and postwar repressions, as well as amending some related acts;

- Government bill on the principles for conducting public fundraising.

THE SEJM REFERRED TO COMMITTEES

- Government bill amending the Road Traffic Act and some related acts;
- Government bill amending the act on the universal duty to defend the Republic of Poland and the act on non-professional soldier salary and some related acts;
- Government bill amending the act on exercise of the legislative initiative by citizens;
- Deputies' bill amending the act on the Institute of National Remembrance – Commission for the Prosecution of Crimes against the Polish Nation and the Penal Code.

THE SEJM ACCEPTED the report on the activity of the Inspector General for the Protection of Personal Data in 2012.

THE SEJM CONSIDERED the current information on anomalies related to public contracts for services related to Polish Presidency in the European Union and the purchase of equipment and ICT services realized by CAM Media SA.

WITH A MOMENT OF SILENCE, THE SEJM HONoured THE MEMORY OF

Wojciech Kilar, who died on 23 December 2013, an outstanding Polish composer and pianist, awarded with the Order of the White Eagle;

Stanisław Dąbrowski, who died on 9 January 2014, First President of the Supreme Court, President of the Tribunal of State, Deputy for the Sejm of the 10th term.
