

## 79<sup>th</sup> SITTING OF THE SEJM, 5–7 NOVEMBER 2014

### THE SEJM PASSED THE ACTS

- amending the act on the turnover of financial instruments and some related acts;
- amending the act on ecological farming;
- amending the act on the freedom of business activity;
- amending the Energy Law and the act on collecting, processing and transferring criminal information;
- amending the act on the National Court Register and some related acts;
- amending the act on the National Emergency Medical Services;
- annulling the act establishing the long-term “Programme for the Oder – 2006.”

### THE SEJM ADOPTED RESOLUTIONS

- establishing the 20<sup>th</sup> of November the National Day of Children’s Rights;
- amending the Standing Orders of the Sejm of the Republic of Poland;
- concerning changes within personal composition of the Special Services Committee.

### THE SEJM CONSIDERED THE SENATE’S RESOLUTIONS CONCERNING THE ACTS

- amending the Attorneys Act and some related acts;
- amending the act on gambling games;
- on facilitating the performance of business activity;
- amending the act on the commercial quality of agricultural products and foodstuffs and the act on the safety of food and nourishment;
- amending the act on prevention of sea pollution by ships and some related acts.

### THE SEJM RETURNED TO THE COMMITTEE

the Deputies’ bill amending the Constitution of the Republic of Poland.

### THE SEJM REFERRED TO COMMITTEES

- Government bill amending the act on money allowance of the social insurance in case of ailments and maternity and some related acts;
- Government draft Restructuring Law;
- Government bill amending the Code of Civil Procedure and the act on court fees in civil cases;
- Senate’s bill amending the Code of Penal Procedure;
- Deputies’ bill amending the Code of Commercial Companies and some related acts;
- Government bill amending particular acts due to the realisation of the Budget Act.

### THE SEJM CONSIDERED IN THE FIRST READING

the Deputies’ bill amending the act on the personal income tax (*the motion to reject the bill shall be subject to a vote at the next sitting of the Sejm*).

### THE SEJM REJECTED IN THE SECOND READING

the Deputies’ bill amending the act on therapeutic activity.

### THE SEJM ACCEPTED

- information of the Council of Ministers on the tasks of Polish foreign policy in the years 2014–2015;
- report submitted by the Minister of Environment on the realisation of the long-term “Świnna Poręba water reservoir construction programme for 2006–2013” in 2013 (*the Sejm did not accept the motion to reject the information submitted at the 78<sup>th</sup> sitting*).

**THE SEJM DID NOT ACCEPT** the motion to recall Deputy Radosław Sikorski from the office of the Marshal of the Sejm of the Republic of Poland.

**THE SEJM CONSIDERED THE CURRENT INFORMATION** concerning conditions and principles for locating the onshore wind farms the principles for the operation thereof.
