

94TH SITTING OF THE SEJM, 10–12 JUNE 2015

THE SEJM PASSED THE ACTS

- on the greenhouse gas emission allowance trading scheme;
- amending the act on particular forms of supporting the housing construction and the act which itself amended the act on warranties and guarantees granted by the State Treasury and particular legal persons, the act on Bank Gospodarstwa Krajowego (National Household Bank) and some related acts;
- amending the act on ownership of premises;
- amending the act on real estate management;
- amending the act on public finances;
- amending the act on the supervision of the capital market and some related acts;
- amending the Accountancy Act and some related acts;
- amending the Code of Penal Procedure and the Petty Offences Procedure Code;
- amending the Code of Penal Procedure;
- amending the act on the Supreme Court;
- amending the act on patients' rights and the Commissioner for Patients' Rights;
- amending the act on the Polish language and the act on the organization and functioning of retirement funds;
- amending the act on disclosing information on the environment and its protection, public participation in the environment protection and environmental impact assessments, and the act on particular principles for preparation and realization of investments in the scope of public roads;
- amending the Industrial Property Law and some related acts;
- amending the act on sports, the act on local taxes and fees and the act on the personal income tax;
- amending the act on tourist services;
- amending the act on gambling games;

THE SEJM REFERRED TO COMMITTEES

- Deputies' bill on considering complaints by financial market entities and on the Financial Commissioner;
- Deputies' bill amending the Banking Law and some related acts (*of the print no. 3425*);
- Deputies' bill amending the Banking Law and some related acts (*of the print no. 3426*);
- Government bill amending the act on the supervision of the financial market, the Banking Law and some related acts;
- Government bill amending the Code of Civil Procedure and some related acts as regards supporting the conciliatory methods for dispute resolution;
- Government bill amending the act on the personal income tax and the act on the corporate income tax;
- Government bill amending the Tax Ordinance and some related acts;

- Government bill amending the act on the Border Guard and some related acts;
- Government bill amending the act on providing protection to foreigners on the territory of the Republic of Poland and some related acts;
- Government bill on supporting the sustainable development of the fishing sector with the participation of the European Maritime and Fisheries Fund.

THE SEJM RETURNED TO COMMITTEES

- Government bill on infertility treatment and Deputies' bill amending the act on acquiring, storing and transplanting cells, tissues and organs;
- Deputies' bill amending the Banking Law and some related acts (*the Sejm did not accept the Committee motion to reject the bill*).

THE SEJM HELD A SECOND READING of the Deputies' draft resolutions concerning: honouring the victims of the May Coup d'État of 1926, honouring the memory of the victims of the May Coup d'État of 1926 (*the Committee motion to reject the draft resolutions shall be subject to a vote at the next sitting of the Sejm*).

THE SEJM HEARD the information of the Prosecutor General as regards the public disclosure of investigation files of illegal wiretapping.

THE SEJM CONSIDERED the Government document "Report on respecting patient's rights on the territory of the Republic of Poland in the period between 1 January 2013 and 31 December 2013" (*the motion to reject the report shall be subject to a vote at the next sitting of the Sejm*).

THE SEJM ACCEPTED the report of the Council of Ministers on the realization of the "Programme for Reducing the Health Consequences of Tobacco Smoking in Poland" in 2013.

THE SEJM CONSIDERED THE CURRENT INFORMATION concerning the oppressive interference of the organs of the state in the parental authority.

THE SEJM ADOPTED RESOLUTIONS

- amending the Standing Orders of the Sejm of the Republic of Poland;
- establishing the 14th of June the National Remembrance Day of the Victims of Nazi German Concentration and Extermination Camps;
- establishing the 1st of July the Day of the Polish Sejm;
- concerning changes within personal composition of the Sejm committees.
